Swap/Rollover: If a trade is kept open overnight, then there is a swap/rollover fee/income calculated on that position. The cost or income is calculated as the overnight interest rate differential between the two currencies on which the position is held, depending on the type of the position (long/short). It is important to remember that one can gain or lose on swap and as such, one has either positive rollover or negative rollover. There is a possibility that some instruments may have negative rollover values on both sides therefore, the positive and negative values are decreased accordingly.

In the trading terminal 'swap' is automatically converted into the balance currency. Operation is conducted between 20:30 – 00:00 GMT. Triple swap is charged on Wednesdays.
